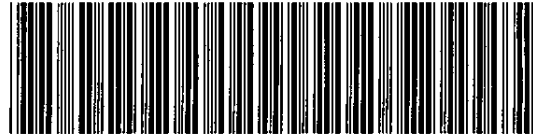



**ARTICLES OF INCORPORATION OF
INTERSTATE SEVEN, INC.**

The undersigned acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: Interstate Seven, Inc.

ARTICLE III: PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are): To transact business pertaining to the provision with the upkeep of the warehouse/condo/grounds and any other related service or business activity authorized by the laws of the State of Florida.
