ARTICLE I NAME

SECRETARY OF STATE The name of the corporation shall be:

FUSION DANCE TROUPE BOOSTER ASSOCIATION, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

As of August 1, 2008 Fusion Dance Troupe Booster Association, Inc. is formed.

Section I: The purpose of this organization shall be to:

a. Develop a closer Fusion Dance Troupe Booster Association, Inc. - parent relationship

b. Assist the John A. Ferguson Senior High School Fusion Dance Troupe program to raise and administer funds for the benefit of the dance troupe members

c. Financially assist with Fusion Dance Troupe Booster Association, Inc., team activities when regular school funds are insufficient

d. Participate and assist with Fusion Dance Troupe Booster Association, Inc., activities as requested by the teams Dance Director

e. Fusion Dance Troupe Booster Association, Inc., is to have the power to do any and all things necessary or expedient to carry out the purpose of the corporation in general, to possess all rights, privileges and immunities and enjoy all benefits granted to corporations of similar character under the laws of the State of Florida, including but not limited to the power to make and enter into contracts, receive and disburse funds granted by federal, state or private agencies or organizations or individuals, make community studies, develop programs, conduct research, develop business, and coordinate, supervise and administer with similar programs and projects as re necessary in furtherance of its corporate purposes.

f. Fusion Dance Troupe Booster Association, Inc., is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section II:

a. Fusion Dance Troupe Booster Association, Inc., shall be guided by the policies set forth by Miami-Dade County Public Schools Booster Club Guidelines, John A. Ferguson Senior High School Fusion Dance Troupe Dance Director and Executive Board of this Association.

b. The principal of John A. Ferguson Senior High School has final authority on the existence of any and all activities of Fusion Dance Troupe Booster Association, Inc.

c. Fusion Dance Troupe Booster Association, Inc., Dance Director is to serve as a liaison and to communicate to the association membership the needs of the program and / or activity.
