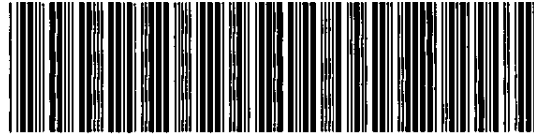

ARTICLE II

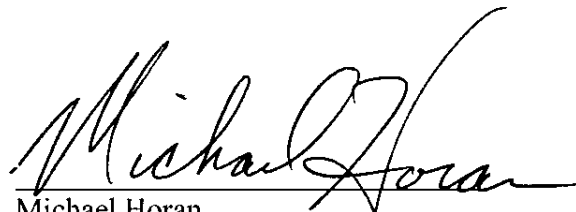
The document number of the Corporation is N08000006999.
