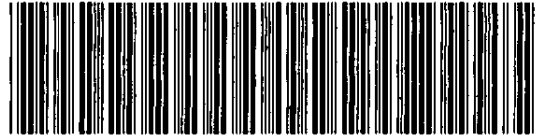

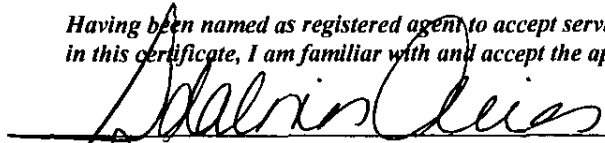

ARTICLES OF INCORPORATION  
(CONTINUED)

**ARTICLE III PURPOSE:**

THIS CORPORATION IS ESTABLISHED TO PROVIDE FOOD, CLOTHING AND LIVING NECESSITIES TO IMPOVERISHED AND HOMELESS IN SOUTH FLORIDA AND IN COLOMBIA.

THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE PURPOSES, INCLUDING FOR SUCH PURPOSE, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE OR ANY CORRESPONDING SECTION OF ANY FUTURE TAX CODE.

NO PROCEEDS OF THE CORPORATION WILL ENRICH ANY INDIVIDUAL, EXCEPT THAT REASONABLE COMPENSATION PAID FOR SERVICES TO THE CORPORATION. IF THE CORPORATION IS DISSOLVED, ANY ASSETS REMAINING WILL BE DISTRIBUTED TO ANOTHER CORPORATION SERVICING A SIMILAR PURPOSE AND QUALIFYING AS A TAX-EXEMPT, CHARITABLE ORGANIZATION UNDER THE PROVISIONS OF 501 (c) (3) OF THE INTERNAL REVENUE CODE.
