ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

Article I: Name

Kraft Tennis Partners , Inc.

Article II: The principal place of business and mailing address:

5425 Florence Point Drive, Amelia Island, Florida, 32034 or place or places as designated by the board of directors.

Article III: The specific purpose or purposes for which the corporation is organized.

The Corporation is organized for all legal purposes under Florida law, and within the meaning of section 501(c)(4) of the Internal Revenue Code, as may be amended, including, but not limited to, the following:

- 1. To provide a legal vehicle that will collect funds from the partners and expend the same funds to build tennis courts for the use and enjoyment of the partners.
- 2. To negotiate and enter into contracts with construction firms to build tennis courts.
- 3. To manage the contractual relationships between "Kraft Tennis Partners" and "Kraft Athletic Club", where the courts will be located.
- 4. To establish rules that will regulate the playing environment among the "partners".
