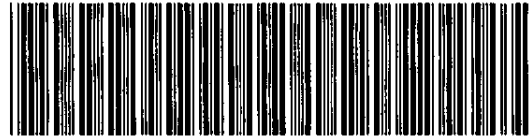

- THIRD: The date dissolution was authorized: April 30, 2013. Effective date of dissolution: July 31, 2013.


FOURTH: Adoption of Dissolution
