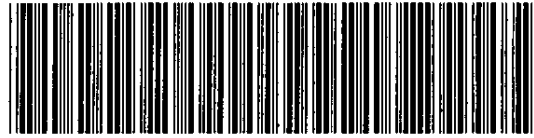

The Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Not for Profit Corporation under the Not for Profit Corporation Law of the State of Florida, do hereby certify:

ARTICLE III CORPORATE PURPOSES

Heaven's House of Joy, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. These purposes include, but are not limited to: empowering of individuals and families through assistance with basic needs from a holistic and spiritual perspective and to promote self-esteem as well as self-sufficiency. The corporation will campaign for, receive, hold, and apply funds, gifts, bequests, endowments or the proceeds thereof to any of the purposes described as well as any and all lawful business for the welfare and benefit of the corporation.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. The property, assets, profits and net income of the Corporation are irrevocably dedicated to religious, charitable, and educational purposes, no part of which shall inure to the benefit of any individual. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. The corporation shall not carry on any other activities not permitted by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this corporation.

Upon the dissolution of the corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, to be used exclusively for charitable, religious, and educational purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


