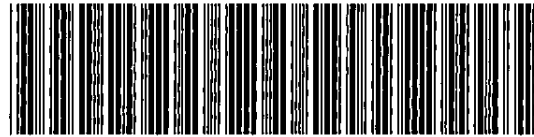

ARTICLES OF INCORPORATION **FILED**

ARTICLE I NAME

The name of the corporation shall be:
Florida Liber Schools Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is exclusively for charitable, education, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earning of the corporations shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporations shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

The corporation intends to operate public charter schools in the State of Florida. The corporation may not discriminate against applicants and students on the basis of race, color, or national or ethnic origin.

ARTICLE IV MANNER OF ELECTION

The Directors shall be elected by majority vote of the Board. The Directors shall serve until removed from office by two-thirds vote of the Board, they submit their resignation in writing to the Chairman of the Board or President, or until the time of their death.
