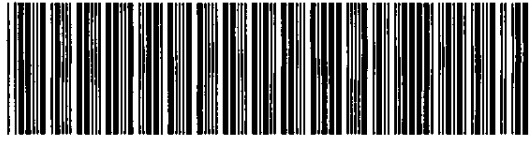

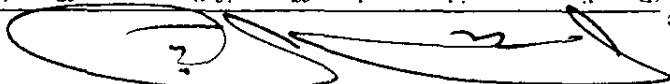

D. Under Article VI, changed directors. Removed Lincoln Crone, and added Preston Davis, address 6267 Old Water Oak Rd., Tallahassee, FL 32312.

Under Article VII, changed officers, as indicated in Articles of Amendment and as follows: remove Richard Weissman, Kumar Jairamdas, and Lincoln Crone as officers in their respective positions as listed in the initial Articles of Incorporation. Add Erin Lauer, address 8535 Quail Rd., Seminole, FL 33777, as President; add Virginia Blum, address 30520 Lynne Dr., Wesley Chapel, FL 33543, as Secretary; add Paula Testa, address 12733 Oakwood Dr., Hudson, FL 34669, as Treasurer.

Further, two additional officer positions are created, a Chief Operating Officer, and a Chief Planning Officer.

E. Added additional statement of corporate purpose under Article II: "To promote the religious traditions, learning, art, and culture of Tibet. Specifically, to promote the teachings and practices held within the Drikung Kagyu lineage of Tibetan Buddhism, in accord with the vision and direction of His Holiness Chetsang Rinpoche and Drupon Thinley Ningpo Rinpoche."
