A FLORIDA NOT FOR PROFIT CORPORATION

ARTICLES OF INCORPORATION (FIRST AMENDMENT)

ARTICLE III

Said corporation is organized exclusively for charitable purposes for the advancement of education, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Specifically, this corporation will raise funds to promote the educational environment of the students at Imagine Schools at Land O' Lakes (non-profit), coordinate parent volunteers to support school activities, develop extra-curricular programs, and purchase material for the enhancement and the educational development of all the students.

ARTICLE V

ARTICLE IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code to the geographically closest Imagine Charter School that has attained non-profit status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. In the absence of such school, assets shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s), as said Court shall determine, which are organized and operated exclusively for such purposes.
