ARTICLE III – PURPOSE (ATTACHMENT)

Section A

This corporation is organized exclusively for charitable, educational, religious and scientific purposes. Including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose of Faith Hope And Determination is to:

- To help save lives and increase awareness in the minority community about the urgent need for new bone marrow and stem cell donors.
- To educate potential donors of the donation process.
- To raise funds and acquire donations to provide financial assistance and support to patients and their families.
- To raise funds and acquire donations to provide scholarships to students pursuing studies and research in the field of blood cancers.

Section B

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section C

Upon the dissolution of the corporation, assets remaining after payment of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes to a like corporation which has established its tax exempt status under Section 501(c)3 of the Internal Revenue Code.
