ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of this corporation pursuant to Chapter 617 of the Florida Statutes, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be **BUSINESS VOICE OF EAST CENTRAL FLORIDA, INC..**

ARTICLE II - TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation with the Secretary of State.

ARTICLE III - ADDRESS OF PRINCIPAL OFFICE

AND MAILING ADDRESS OF CORPORATION

The address of the principal office of the corporation is **1005 E. NEW HAVEN AVENUE, MELBOURNE, FL 32901**, and the mailing address of the corporation is **1005 E. NEW HAVEN AVENUE, MELBOURNE, FL 32901**.

ARTICLE IV - PURPOSES AND POWERS OF CORPORATION

- A. The corporation has been formed for the following purposes:
1. To educate its members about political candidates and issues affecting matters of interest and concern to the corporation.
 2. To assist its members in organizing themselves for effective political action.

3. To make contributions to political committees, political parties, electioneering communications organizations, or to individuals seeking state or local office to the extent permitted by law.
4. To do any and all things necessary or desirable to further through the political process the interest of its members.

B. This corporation shall be authorized to carry out any and all acts and to exercise any and all corporate powers which may now or hereafter be lawful under the laws of the State of Florida to the extent applicable to corporations not for profit and that are not inconsistent with these Articles of Incorporation.

ARTICLE V - ELECTION OF DIRECTORS

The Board of Directors of the corporation shall be elected as provided in the Bylaws.
The Board of Directors shall at all times consist of at least three (3) persons.

ARTICLE VI - INITIAL REGISTERED OFFICE

AND REGISTERED AGENT

The street address of the initial registered office of the corporation is **360 NORTH BABCOCK STREET, SUITE 104, MELBOURNE, FL 32935** , and the name of the initial registered agent of this corporation at that address is **JOEL E. BOYD**. The Board of Directors may from time to time designate a new registered office and registered agent.

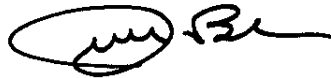

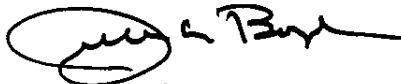
