# ARTICLES OF INCORPORATION OF GRAND LAGOON NATIONAL FOUNDATION THREE, INC., a Florida corporation not for profit

The undersigned, acting as incorporator of a corporation not for profit under the Florida Not For Profit Corporations Act, as set forth in Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation for such corporation:

### **ARTICLE I. NAME**

The name of this corporation is **Grand Lagoon National Foundation Three, Inc.**, (referred to herein as the "Corporation").

### ARTICLE II. TERM OF EXISTENCE

The Corporation shall exist perpetually or until terminated as provided by law.

### ARTICLE III. ADDRESS OF CORPORATION

The mailing address of the Corporation and the street address of the initial principal of fice is 1120 West Beach Drive, Panama City, Florida 32401.

### ARTICLE IV. PURPOSE

The general nature, objects and purposes of the Corporation are:

- (1) The general purpose for which this Corporation is formed is to operate exclusively for charitable purposes, including, the making of distributions to organizations which qualify as tax exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any subsequent federal tax laws;
- (2) The specific purpose for which this Corporation is formed is to raise money for local charities by organizing, hosting, promoting and supervising fishing tournaments and other events conducted on or to the benefit of marinas and other businesses located on the Grand Lagoon in Panama City Beach, Florida; and

(3) To operate without profit; the property of this Corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this Corporation shall ever inure to the benefit of or be distributed to any director, officer, member, trustee or other private individual.

### **ARTICLE V. MEMBERS**

The Corporation shall have a membership distinct from the Board of Directors. The authorized number and qualifications of the Members of the Corporation, the manner of their admission, the different classes of membership, if any, the property, voting and other rights and privileges of Members, and their liability for dues and assessments and the method of collecting dues and assessments shall be as regulated in the Bylaws of the Corporation.

# ARTICLE VI. INITIAL REGISTERED AGENT AND REGISTERED OFFICE

The name of the initial registered agent of the Corporation is William F. Spann, and the street address of the initial registered office of the Corporation is 1120 West Beach Drive, Panama City, Florida 32401.

### ARTICLE VII. FIRST BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors. The Board of Directors shall initially consist of ten (10) directors. The number of directors may either increase or decease from time to time, by a method of election as stated in the Bylaws, but shall never be less than three (3). The directors named here as the first Board of Directors shall hold office until the first meeting of the Members. Thereafter, the election or appointment of the Board of Directors shall be regulated in accordance with the By-Laws of the Corporation.
