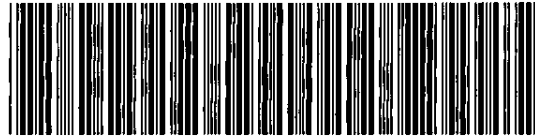

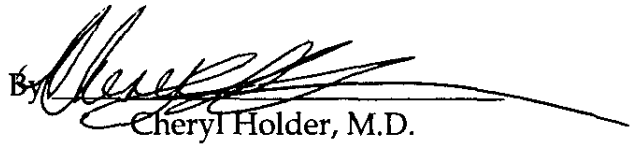

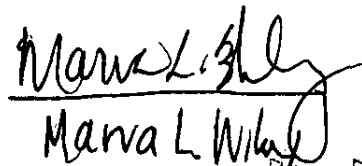
ARTICLE VIII
