Pursuant to Section 617.1006 of the Florida Statutes, the undersigned not-for-profit corporation hereby adopts the following articles of amendment to its Articles of Incorporation:

FIRST: The name of the corporation is GOLDEN OAK ESTATES NON-RESIDENTIAL ASSOCIATION, INC.

SECOND: The Articles of Incorporation of this corporation are amended by changing Article 1 so that, as amended, said Article 1 shall read as follows:

ARTICLE 1

NAME OF CORPORATION

The name of this corporation shall be GOLDEN OAK NON-RESIDENTIAL ASSOCIATION, INC., a Florida not-for-profit corporation (the "**Non-Residential Association**"), whose principal address and mailing address shall initially be 1375 Buena Vista Drive, Lake Buena Vista, Florida 32830.

THIRD: The amendment to the Articles of Incorporation of the Corporation set forth above was adopted by unanimous written consent of the Board of Directors of the Corporation on November 20, 2009. The members of the Corporation were not entitled to vote on the amendment.
