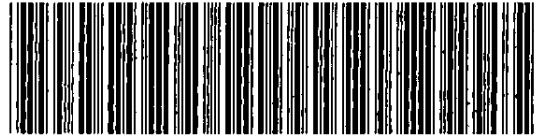

ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be:

Freedom Missionary Baptist Church of Melbourne, Incorporated

The principal place of business of this corporation shall be:

2904 South Harbor City Boulevard Melbourne, Florida 32901

ARTICLE II

The period of the duration of this corporation is perpetual "Filing with the Secretary of State unless dissolved according to law and shall engage in the activity or business permitted a non-profit entity under the laws of the United States and of the State of Florida.

ARTICLE III

The purpose (purposes) for which the corporation is organized is (are): The strengthening and deepening of the spiritual lives of its members, thereby enabling them to develop to the highest degree of spiritual endowment attainable in this life, (Matthew 5:14-16). It is also the practice of this church to ordain Bishops, Elders and Deacons, to license male and female ministers, to administer The Lord's Supper, accompanied by feet washing as administered by Christ Himself and as practiced by the Holy Apostles; To perform marriage ceremonies and permit divorces on Bible grounds; to conduct funerals and bury the dead; to extend charity, stimulate education, fight vice and wickedness and to guide humanity in its search for a full rewarding life through the complete surrender to Jesus Christ. This church shall also exercise control over its own property and business affairs so as to safeguard its interests.

This is a non-stock, non-profit corporation. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from the Federal income tax under section 501 (C) (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Revenue law.

In keeping with the organization's exempt purposes and to further the religious, charitable, scientific, literary, and educational purposes, we will establish a day care center for the education and welfare of our community. In addition, to help train others in the Gospel ministry, we will establish and promote a Bible college also in keeping with our exempt purposes.

ARTICLE IV

The qualifications for members and the manner of their admission are: The conditions for membership shall be stated in the constitution and bylaws.

ARTICLE V

The number constituting the initial Board of directors of the corporation is three (3) and the names and addresses of the persons who are to serve initially are: (not less than 3)

ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay a reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, or intervene in (including the publishing or distribution statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from the federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for the exclusive public purpose.


ARTICLE IX
