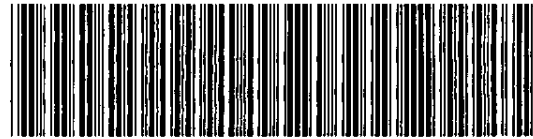

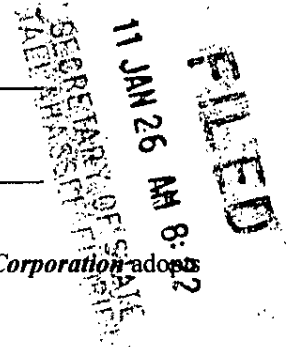

The articles of incorporation of the non-for-profit corporation is hereby amended by deleted

Article III in its entirety and inserting, in lieu thereof, the following:

"Article III-The specific purpose for which this corporation is organized is: a:To work to bring all souls to Christ while working to end physical and spiritual poverty in Florida and beyond through integrated development.

b:Said organization is organized exclusively for charitable,religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

c:Upon the dissolution of the organization,assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government,or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall(continued on pge2a)

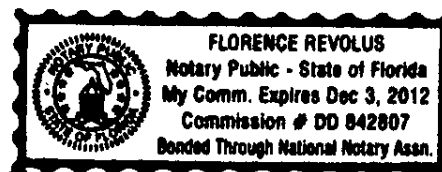
