## Change to Articles of Amendment

#### Dear Sir:

The following changes were voted on by the board and approved on August 28, 2009:

#### 1A. Amendment to Article #III

The Mary L Jones Land Trust Inc. is organized exclusively for the development of charitable purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### 1B. Amendment to Article # III

Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carries on, (a) by a corporation exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### 1C. Amendment to Article # III

The specifs purpose of this organization is the development of affordable moderate and low income housing and community economical development for charitable purposes. This is to be done by reducing the land cost of the development and passing the saving on to the end user.

#### Article #IX:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustee, officer, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payable and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda; the corporation shall limit its attempting to influence political legislation unless the legislation is a direct benefit to the corporation and in the corporation's best interest.

#### Article #X

Upon the dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state, local government, CHDO or other non-profit organization for the

development or re-development of distress communities for public purpose or for the development of low or moderate income housing.

#### Article #XI

When Compensation is applied the following will be the general rule of operation unless change by the Board of Directors. Compensation for Officer, Board Members shall never be more than 20% of the net profit of the organization and must be approved by a majority vote. Compensation for Dept. Directors and other personnel will be determine by the president of the organization and a budget will be submitted for approval by the Board of Directors this total budget will not exceed 25% of the organization net profit.
