

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: THE MISSION COMMUNITY, INC.

ARTICLE III PURPOSE

The purpose for which the corporation is organized:

The Mission is organized exclusively for providing religious and educational instruction, and charitable assistance within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law). The Mission will pursue these objectives by:

The Mission Community Inc; 'is a lay missionary community' for "fostering the Mission activities of the Catholic Church and supporting the Missionaries" all over the world. We come together for the great Mission: "World Evangelization". Helping the Teenagers, Youth & Young Families to experience Christ's love is our primary objective. ARTICLE VIII

10.1 Upon the dissolution of the Mission, the Board of Directors shall take the necessary steps to pay all liabilities and obligations of the Mission. If its property and assets are not sufficient to satisfy or discharge the Mission's liabilities and obligations, the Mission shall apply them so far as they will go to the just and equitable payment of the liabilities and obligations.

DIVISION OF CORPURATION

10.2 Assets held by the Mission upon conditions requiring return, transfer, or conveyance, which condition occurs by reason of dissolution, must be returned, transferred or conveyed in accordance with such requirements.

10.3 The remaining assets of the Mission shall distribute as follows, instead of pursuant to the provision of 805 ILCS 105/112.16 OF FLORIDA GENERAL NOT FOR PROFIT CORPORTATION ACT OF 1986 or pursuant to a successor statute:

(1) If another The Mission Community Inc. organization then exists in United States of America which is exempt under Section 501 (C) (3) of the Internal Revenue Code of 1986, as amended, or their successor statute, then all remaining assets shall be distributed only for tax exempt purposes to The Mission Community Inc., PARISH or organizations as determined of a majority of the Board of Directors

ARTICLE IX

ADDITIONAL PROVISIONS

Resolved that any salaries, wages, together with fringe benefits or other forms of compensation (housing, transportation, and other allowances) paid to or provided our employees, directors, or officers will not exceed a value which is reasonable and commensurate with the duties and working hours associated with such employment and with the compensation ordinarily paid persons with similar positions or duties.

- a. Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.
- b. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- c. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by a court of common please of the county in which the principal office of the organization is then located,

exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X

Any amendment to the above articles shall only be made with the approval of two thirds majority of members present in a general body meeting of the mission held with at least 15 day notice informing the proposed changes.
