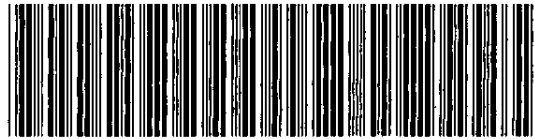

ARTICLE XI


