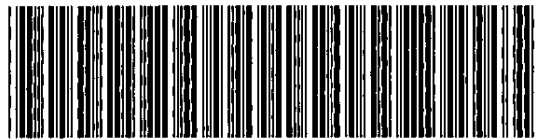



The undersigned incorporator hereby files the following Articles of Incorporation:
