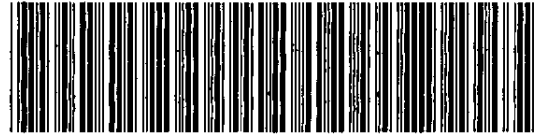



OF INCORPORATION

We the undersigned have this day voluntarily associated ourselves for the purpose of forming/domesticating a "domestic nonprofit corporation" under the laws of the State of Florida. To that end do hereby adopt articles of incorporation as follows.

ARTICLE I

The name of the corporation shall be:

SAFARI THROUGH THE WORD MINISTRIES INC.

ARTICLE II

The principal place of business/mailing address is:

ARTICLE III

The purpose for which the corporation is organized is: To operate as a domestic nonprofit corporation and is not organized for the private gain of any person. It is organized under the nonprofit religious laws within the meaning of Section 501(c)(3) of the Internal Revenue Code.

- (a) The object and purpose of this domestic nonprofit corporation is to conduct any and all manner and kind of business for which a domestic nonprofit corporation may be incorporated under the laws of the State of Florida and under Section 501(c)(3) of the Internal Revenue Code.
- (b) The character of business, which this corporation intends to conduct, is to provide churches, homes, and other places of worship, be it for individuals or groups of people, with the ministry of the gospel of the Word of God in all of its written and spoken forms. Secondly, it is to encourage by the teaching and ministering of religious principles in the Word of God, Christian education, and the use of world events, peoples of all nationalities, in a global setting, who wish to participate within the purposes and direction of this corporation.
- (c) To establish either "one day" individual teaching sessions, or "multiple days or weeks in length" seminars and conferences for the purpose of religious, educational and community benefit such as shall be according to the approved purposes and to the furtherance of this corporation. To receive grants, gifts, tithes and offerings, gifts by will or bequeath, to the furtherance of this organization and it's corporate purposes as stated in these articles. To be a charitable organization that will give tithes, offerings and gifts to other individuals or organizations in accordance to the approved designations and purposes and the furtherance of this corporation.
- (d) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers or any private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes for which it was formed.

- (e) No substantial part of the activities of the corporation shall be carrying on propaganda otherwise attempting to influence legislation. The corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future Internal Revenue Law) or (b) by a corporation distributions which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provisions of future United States Internal Revenue Law).
- (f) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.
