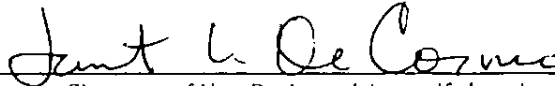

Railroad Square Art Park in Tallahassee, FL. These members will call for volunteers to serve on the board of directors
and elect corporate officers. Directors shall serve one-year terms, and the future Board of Directors shall select
subsequent directors by a majority vote."

ADD A NEW FOURTH ARTICLE OF INCORPORATION:

"Membership is open to all, but primarily for educational, artistic, historical and cultural individuals and groups who reside
in the South side of Tallahassee. These members will call for volunteers to serve on the board of directors and elect
corporate officers. Directors shall serve unlimited terms unless and until the Board of Directors deem them ineffective
and select subsequent directors by a majority vote."
