ARTICLES OF INCORPORATION OF CHARLIE PERKINS FAMILY MINISTRIES, INC. (A CORPORATION NOT-FOR-PROFIT)

I, the undersigned, being a natural person, hereby establish a corporation under Chapter 617, Florida Statutes, as amended, of the Laws of the State of Florida applicable to corporations not-for-profit and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation.

ARTICLES 1 - NAME

The name of this corporation is, hereinafter called "corporation," shall be CHARLIE PERKINS FAMILY MINISTRIES, INC.

ARTICLE II - PURPOSE

Section 1:

The purpose for which the Corporation is founded are:

- (a) Provide food services for the homeless

ARTICLES III - POWERS

This Corporation is to have any and all powers to do any and all things necessary or expedient to carry out the purposes and objectives of this corporation, subject to these Articles of Incorporation and Bylaws, and shall possess all rights, privileges and immunities and to enjoy all benefits granted corporations under the Laws of the State of Florida, but limited only to such powers that are in furtherance of tax exempt purposes.

ARTICLES IV - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V - PRINCIPAL OFFICE

The principle office of this Corporation shall be located at 415 S. Wiggins Road, City of Plant City, County of Hillsborough, State of Florida, 33566 provided that the corporation shall have the power to conduct its business anywhere within or outside the State of Florida or the United States of America.

<u>ARTICLE VI – MEMBERSHIP</u>

Section 1: The Corporation is to be organized upon a non-stock, certificate

of membership basis. Such memberships shall be non-redcemable,

non-transferable, and non-divided bearing.

Section 2: Any personal that subscribes to the purposes of this corporation is

eligible for membership upon approval by a majority vote of the

corporation at any regular meetings of the corporation.

ARTICLES VIII - BOARD OF DIRECTORS

Section 1: The affairs of the Corporation shall be directed by a Board of

Directors numbering not less than one (1) nor more than ten (10) members. Each member of the Board of Directors shall be elected By the members of the Corporation as prescribed by the Bylaws.

Section 2: The names, title, and addresses of the persons constituting the first

ARTICLE IX - OFFICERS
