# **ARTICLES OF AMENDMENT:**

### ALL THINGS COMMON MINISTRIES, INC.

(A Florida Not for Profit Corporation)

ALL THINGS COMMON MINISTERIES, INC. filed its original Articles of Incorporation on August 8, 2008. The "document number" assigned to this organization by the Florida Department of State at the time of incorporation was N08000007726. The Board of Directors adopted these Articles of Amendment at a regular meeting with a quorum being present which was held on November 1st , 2020. This board meeting met the requirements of both the Articles of Incorporation and the bylaws. There is no membership. The Board of Directors is self-perpetuating.

The Articles of Incorporation of ALL THINGS COMMON MINISTERIES, INC. are hereby amended by

- 1. Correcting the spelling of its name in Article I from Ministeries to Ministries
- 2. Changing Article IV, Manner of Election, to read as follows: The method of selection of the Board of Directors and number of directors shall be stated in the bylaws.
- 3. Adding Article VIII, as follows:

#### ARTICLE VIII

- A. The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future U. S. Internal Revenue law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. No substantial

part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

- The corporation shall not distribute any gains, profits or dividends to the directors, officers or to any individual except as reasonable compensation for services actually performed in carrying out the corporation's charitable and educational purposes. The property, assets, profits and net income of the corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.
- In the event of dissolution, the residual assets D. of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170 (c)(2) of the Internal Revenue Code or to the Federal, State or local government for exclusive public purpose.
