**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
RESIDENTS ENCOUNTER CHRIST OF CENTRAL FLORIDA INC.**  
(a Florida Corporation Not for Profit)

Pursuant to Sections 617.1006, *Florida Statutes*, Residents Encounter Christ of Central Florida, Inc., a Florida not-for-profit corporation (the "Corporation"), which bears Florida Document Number N08000007780, adopts the following amendment to its Articles of Incorporation

**FIRST:** Article 1, Name of the Corporation's Articles of Incorporation is deleted in its entirety and the following shall be substituted in lieu thereof:

**ARTICLE 1.**  
Name

The name of this Corporation is Residents Encounter Christ of Florida, Inc.  
(hereinafter called the "Corporation").

**SECOND:** There are no members entitled to vote on this Amendment. This Amendment and the corresponding name change were approved by the Corporation by Unanimous Written Action dated August, 2011, duly executed by all of the Corporation's Directors entitled to vote on such matter.

**THIRD:** The effective date of this Amendment is the date of filing of these Articles of Amendment.
