**ARTICLES OF INCORPORATION OF
"THE SAN LUIS COMMISSION, Inc", a Florida corporation not-for-profit**

The name of the corporation not for profit is "The San Luis Commission, Inc."
The street address of the initial principal office is 145 Harbor Drive, Key Biscayne, Florida 33149. The mailing address is the same.
The background for the reasons that this entity is being incorporated, and the purpose for which it now organized is as follows:

BACKGROUND:

The "San Luis" was the name of a ship carrying hundreds of Jewish families fleeing from Nazi Europe in the year 1928. Prominent members of the Cuban-Hebrew community of South Florida, New York and Washington, D.C. while visiting the Holocaust Museum in Washington noted that the tragic saga of the San Luis, while adequately reported, omitted to set forth the vallant efforts of the Hebrew community in Cuba to persuade the civil government to allow the entrance of the Jewish passengers into this Caribbean Island. Their quest was unsuccessful and the ship was ordered to leave the island, allegedly at the request of the U.S. ambassador. . The vessel was denied entrance into other Caribbean countries, and finally denied entrance into the U.S. The doomed passengers were forced to return to France and ended as still more victims of the Holocaust. A particularly horrifying ending to what could have been a blissful event for both the passengers of the ship and the Hebrew community in Cuba

Jewish community leaders in South Florida asked the trustees of the Holocaust Museum to enlarge the San Luis narrative and include the issue of the Cuban Jews efforts on behalf of those seeking asylum. The trustees are willing to do so provided that adequate proof thereof is submitted to the Museum's curators.

PURPOSE:

It is in response to this request that the investigative commission has been established.

The commission will conduct a thorough, exhaustive research into the efforts of the Cuban-Hebrew community to prevent the forced departure of the San Luis. The objective of this project is to develop factual evidence of these efforts in order to submit a proper report to the Washington Holocaust Museum's trustees and allow them to so show on their public records and exhibition.

There are no reliable records available on the Internet. The research must be conducted by studying records that may be available dating back to the time of the occurrence. Newspapers, archives, official Cuban records, and the official Cuban historian and custodian of the public records, as well as sources in Mexico and Puerto Rico.

The members of the commission shall be volunteers and are free to resign at any time. There are no corporate dues but the members must personally cover all of their travel and research related expenses. The corporation may accept monetary contributions but will not solicit any.

The initial members of the corporation, as set in its by-laws, shall by simple majority appoint three directors or ratify the appointment of the initial directors. Directors are willing members of the commission. The directors shall ask any qualified member to accept the position of coordinator of activities. The coordinator shall act on a voluntary basis, at the pleasure of the directors. The task is no small one, but those who accept to become members of the commission, will carry forth until the facts are established to the satisfaction of the Washington Holocaust Museum.

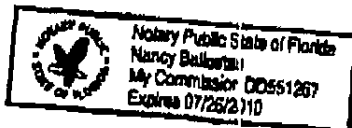
