The Undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Florida, do herby certify:

FIRST: The name of said corporation shall be CitiGreen, Inc.

SECOND: The place in Florida where the principal office of the corporation is to be located at 3016 Martin St. Orlando, FL 32806

THIRD: The purposes for which said corporation is formed are:

CitiGreen is being established to provide education and assistance in the area of high efficiency, low emission buildings. The program will partner with OHA, HUD, Habitat for Humanity, local builders, and major media outlets in Central Florida.

CitiGreen is committed to bringing low emitting, high efficiency products and techniques to low and middle income residents. By increasing education to builders and influencing local authorities to adopt practical efficient building codes, building "Green" will no longer be not a luxury, but a standard. 
