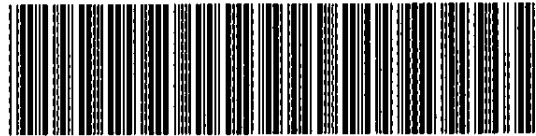

**ARTICLES OF INCORPORATION OF  
THE OPEN SOURCE MEDICINE FOUNDATION, INC.**  
A Florida Not For Profit Corporation

**THESE ARTICLES OF INCORPORATION** of the undersigned incorporator a citizen of the United States, desiring to form a Non-Profit Corporation under Chapter 617, Florida Statutes, the not for profit corporation law of the State of Florida, does hereby certify:

**ARTICLE I            CORPORATE NAME**

The name of the Corporation shall be:

**THE OPEN SOURCE MEDICINE FOUNDATION, INC.**

**ARTICLE II            PRINCIPAL OFFICE**

The place in this state where the principal office of the Corporation is to be located is:

Tallahassee, FL 32308

**ARTICLE III            CORPORATE PURPOSE**

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV            APPOINTMENT OF DIRECTORS**

The Incorporator shall appoint the initial Board of Directors which shall consist of not less than 3 members at any given time. After the initial Board of Directors has approved Bylaws, appointments and replacements of Board members shall be made in accordance with the Bylaws.

**ARTICLE V                    RESTRICTIONS ON CORPORATE ACTIVITIES,  
DISTRIBUTIONS AND EXPENDITURES CONSISTENT  
WITH 501(c)(3) CHARITABLE PURPOSES**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE VI                  DISSOLUTION**

Upon the dissolution of the corporation, its assets shall be distributed to another not for profit organization authorized as a tax exempt organization under section 501(c)(3) of the Internal Revenue Code, or to an agency of the State of Florida, or the United States.

**ARTICLE VII                NAME AND STREET ADDRESS OF REGISTERED AGENT**

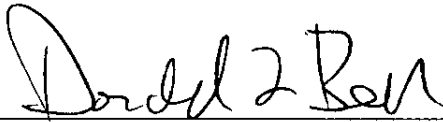
