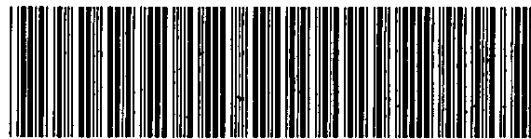

## **Articles of Incorporation (cont)**

### **Article VIII Dissolution of Assets**

Upon dissolution of the Corporation, the Board shall, after paying or making provisions for the payment of all its liabilities, dispose of all its assets exclusively for the purposes of the Corporation, in such manner and to such organization or organizations organized and operated exclusively for religious, educational or charitable purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the IRS Code as the Board shall determine. Any such assets not so disposed shall be disbursed by the court of general jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as the said court shall determine, that are organized and operated exclusively for such purposes.
