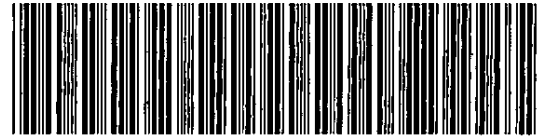

Articles of Incorporation: Dissolution of assets provision

The distribution of assets upon dissolution or final liquidation shall be as follows:
GRACE COVENANT CHURCH INTERNATIONAL, INC. shall be perpetual, upon dissolution of **GRACE COVENANT CHURCH INTERNATIONAL, INC.** assets shall be distributed to one or more designated exempt, not for profit organization(s) within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
