meeting in January of the odd years. Vote shall be by voice or ballot and plurality shall elect.

Section 3. All officers shall be elected for a two (2) year term, subject to re-election for one term only. This requirement may be specifically modified by a majority vote of the membership present. The Treasurer shall serve until replaced.

EXECUTIVE OFFICERS and BOARD OF DIRECTORS

- Section 1. The Executive officers shall consist of a President, Vice President, and Secretary and/or Treasurer and/or Secretary/Treasurer.
- Section 2. The Board of Directors shall consist of the Executive officers, standing committee chairs and the two Directors at Large.

This Board shall discuss plans for the welfare and improvement of the Friends, recommend to the Friends for action any proposed business transactions or changes in Friends policy. The Board of Directors shall have the power to make such appropriations from the treasury not provided in the budget, not to exceed four hundred and ninety-nine dollars (\$499.00). Should a vacancy occur in any office during the two year term, the Board of Directors shall have the authority to appoint someone to serve in that office for the unexpired term.

DUTIES OF ELECTED OFFICERS

- Section 1. The President shall preside at all meetings of the Friends and of the Board of Directors; shall appoint all committees not otherwise provided for; shall perform such duties as the members shall assign; and shall serve as ex-officio member of all committees except the Nominating committee.
- Section 2. The Vice President shall assist the President, and shall perform the duties of the President in his/her absence or inability to serve. This person shall perform such other duties as may be required from time to time by the Board of Directors.
- Section 3. The Secretary shall keep accurate minutes of all meetings of the Friends and of the Board of Directors. This person will have custody of all Friends records and will handle or direct all correspondence.
- Section 4. The Treasurer shall have charge of all monies and pay all bills incurred by the Friends. This person will collect all dues and gifts, keep accurate records and submit annual reports to the Friends and interim reports to the Board. This person shall be a member of the Budget Committee. Books shall be audited yearly.

BY-LAW AMENDMENTS

By-laws may be amended, altered or repealed, in whole or in part, by a majority vote of the members provided 30 days notice or proposed changes has been given.

PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Roberts Rules of Order newly revised shall govern the Friends in all cases where applicable and where they conform to the Charter.

MEETINGS

- Section 1. The annual meeting of the organization will be held in January.
- Section 2. The Board of Directors meetings will be held monthly. All current members are invited to attend.
- Section 3. Special meeting of the organization or the Board may be called by the President.
- Section 4. A quorum of any meeting will be three (3) members of the Executive Committee.
