ARTICLE 1

NAME

1. Name. The name of the corporation is Ollie Owl Booster Club, Corp. (hereinafter referred to as the "Corporation"). The principal place of business of the Corporation is 14250 N.W. 67th Avenue. Miani Lakes, FL 33014

ARTICLE 2

PURPOSE

2. <u>Purpose</u>. The purposes for which the Corporation is organized are as follows:

To operate as a corporation not-for-profit pursuant to Chapter 617 of the Florida Statutes.

To hold funds for the exclusive benefit of the Member Clubs and Activities of the Corporation and pay all expenses incurred in accomplishing or exercising, as the case may be, the purposes and powers of the Corporation.

To open and maintain bank accounts to hold and transmit funds raised for the benefit of Corporation.

To honor and perform all contracts and agreements entered between third-parties and the Corporation.
