The Ecclesiastical Society in accordance with Section 2262 of the Revised Statute of Florida 1892

This dissolution is sought after due consideration and proper action on the part of the said Ecclesiastical Society, that the said Church may take charge of its own temporalities and assume the obligations of this Incorporation, its Society, a Corporation not for profit. The Society moves further unto Your Honor that the only property owned by it is a Church building situated at Panama, Florida, and that there are no obligations nor liabilities resting upon said Society except of strictly a moral nature, and that the said Church is willing to assume these moral obligations.
