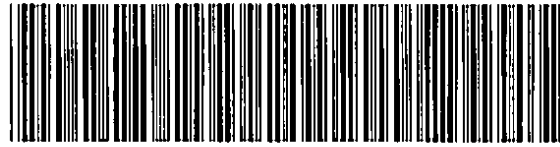

The Eminent Commander conducted a school of instruction which we all need.




