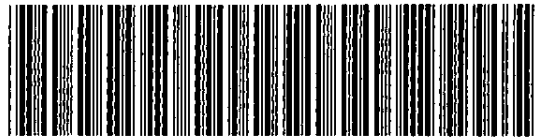



To engage in social, fraternal and sport activities among the members and the community, as well as to provide moral support and assistance to those members in need.






