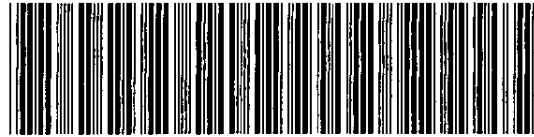

**Article I: Name**

The name of the corporation shall be **Sun City Center Fall Prevention Coalition, Inc.**

**Article II: Principal Office**

The principal place of business where meetings are held, is the Sun City Center Retirement Residence at 3855 Upper Creek Drive in Sun City Center, FL 33573.  
The mailing address is **P.O. Box 5922, Sun City Center, FL 33573-5922**

**Article III: Purpose**

The purpose of the club is to raise awareness of the danger of falling and educate the members of the community on how to reduce their chances of falling.

**Article IV: Dissolution of Assets**

If at any time in the future that this organization disbands and discontinues to function, all remaining assets shall be evenly divided between The Community Foundation, The SCC Emergency Squad and The SCC Men's Club.

**Article V: Manner of Election**

A nominating committee consisting of 2 members shall be appointed by the President to develop a slate of candidates. The candidates for officers shall be presented at a general meeting. Nominations from the floor will also be accepted. Elections shall be held annually in December with new officers beginning their term the following month.

**Article VI: Initial Officers**

This club shall be governed by elected officers comprised of a President, Vice President, Secretary and Treasurer. Their duties are:

President – presides over meetings and have general supervision of Club affairs.

Vice-President – shall assist the President and assume such duties in the President's absence.

Treasurer – shall have custody of monies of the club, maintain records of income and disbursements, liabilities and balances as required.

Secretary – will issue notices of interest, take minutes of meetings and record decisions related to the club and be responsible for general correspondence.
