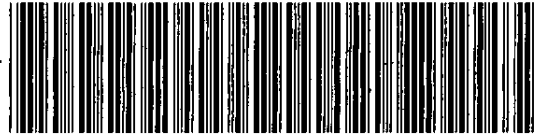

ARTICLE III- PURPOSE

1. Kidz Horizon, Inc.'s purpose is to help young adults ages 5 to 14 to succeed in school by providing homework support and quiet reading time everyday. ARTICLE VIII- DISSOLUTION

1. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
