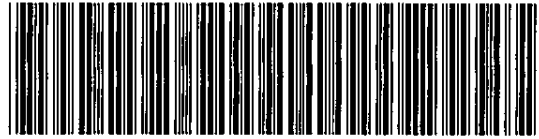

ARTICLE VIII: RESTRICTIONS ON ACTIVITIES


