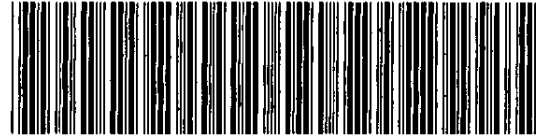

ARTICLES OF INCORPORATION

OF

TABERNACLE OF PRAISE CHURCH OF GOD MINISTRIES, INC.

The undersigned, all of whom are citizens of the United States, desiring to form a corporation, pursuant to the Florida Nonprofit Corporation Code, under Chapter 617, F.S. (not-for-profit)

ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE II – PRINCIPAL OFFICE LOCATION

The principal place of business and mailing address of the corporation shall be:

ARTICLE III - PURPOSE

Tabernacle of Praise Church of God Ministries, Inc. is organized and operates exclusive for religious purposes within the meaning of Section 501C(3) of the Internal Revenue Code and shall not carry on any other activities not permitted to carry on by a corporation exempt from federal income tax under Section 501C(3) of the Internal Revenue Code

The purpose of *Tabernacle of Praise Church of God Ministries, Inc.* is to:

- Provide a place of worship to all people and establish the foundation to help people develop a solid relationship with Jesus Christ as Lord and Savior through profound preaching and teaching from the Word of God. 




