ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of LEANN WHITE FOUNDATION, INC



Pursuant to the provision of Chapter 617, Florida Statutes, the Undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Article VI is amended to add the follows:

"Upon the dissolution and winding up of the organization (Corporation), after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to NATIONAL CYSTIC FIBROSIS FOUNDATION. However, if the named recipient is not then in existence or no longer a qualified distribute, or unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code of 1986 and which has established its tax-exempt status under that section or corresponding section of any future federal tax code; or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed off by a Court of Competent Jurisdiction of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine."
