Articles of Incorporation

ARTICLE I- NAME

The name of the organization shall be the, Wildcat Band Booster Association, Inc. and will be hereafter referred to as "association". This association is a non-profit organization.

ARTICLE II- PURPOSE

The purpose of the organization shall be to enlist the cooperation of parents, school and the community for the purpose of actively supporting and promoting the band students, band program and band Director of Western High School and for all other lawful purposes. The organization shall be of perpetual duration.

ARTICLE III- MEMBERSHIP

The association considers every active parent as being a member of the association. Active is defined as any band parent(s) or guardian(s) at Western High School who is enrolled in a committee and takes an active role with the students.

ARTICLE IV- BOARD OF DIRECTORS

Section 1: The Board of Directors shall be composed of four (4) elected officers of the membership. The officer's term shall be for duration of one year. The initial Board of Directors shall be

Section 2: General elections are held during the Band Parents Association meeting in June, the exact date to be determined by the president of the association. All band parents, whether member of the association or not, are eligible to vote.

ARTICLE V- ELECTIONS

Section 1. Qualifications for elections: Those persons nominated for those positions of officers and directors, either by the membership or the general band parents prior to the close of nominations, shall be qualified for those positions by being an active member of the association, and openly willing to serve if elected.

Section 2. Election procedures: The Board of Directors shall be elected by a majority vote of the attendees during the regular membership meeting in June of each year. President shall call for nominations from the floor at the June meeting, but no name shall be placed in nomination without the consent of the nominee.

Section 3. Only one (1) adult member of a family may serve on the board of directors at any time.

Section 4. Vacancies and or removals in the board shall be filled upon the recommendation of the board of directors to the association by a majority vote of attendees at its next regular meeting.

Section 5: Recommendations for removal of a board member shall be presented at a general meeting and be approved by a majority vote.

ARTICLE VI- REGISTERED AGENT AND PRINCIPAL OFFICE
