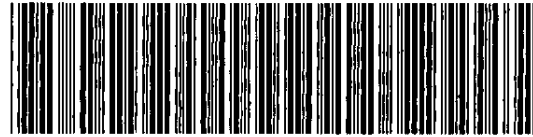

Constitution and By-Laws of
Mission Flight New England

The Organization shall consist of no less than a President, and a Secretary- Treasurer. We will welcome and encourage members.

No activities shall be performed or expenses paid unless approved by a majority of all members.

There shall be an annual meeting for the purpose of conducting business and approving all activities and expenditures with any decisions recorded and reviewed and approved by a majority vote of all members. Dates to be agreed on by all members.

Our purpose is to provide transportation at no cost to missionaries and like speakers while they are raising funds to fulfill their mission and to provide educational training to youth using aviation tools to provide teaching of good life application skills.

We shall raise funds through grants and donations and fund-raising events. All collected proceeds will pay for costs of rental, purchase and operations of a helicopter and cover all other expenses associated with common bills and materials.

Any pilot will only be paid for flying when- transporting missionaries, fund raising and required maintenance or services are needed and only when holding a commercial license.

For missionaries to qualify for services they must need to travel a distance and time that would be difficult to accomplish by car such as multiple meetings in a single day that are several miles apart. Other charitable transportation would have to be approved by the board.

No unsafe flights will be conducted. If the pilot deems the trip unsafe due to weather or location, the service will not be provided.
