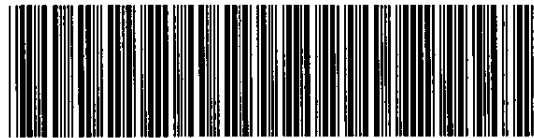

**ARTICLES OF INCORPORATION**

**OF**

THE UNDERSIGNED, BEING OF LEGAL AND COMPETENT CONTRACT, FOR THE PURPOSE OF ORGANIZING A NOT FOR PROFIT CORPORATION PURSUANT TO THE LAWS OF THE STATE OF FLORIDA, DO HEREBY STATE THE ARTICLES OF INCORPORATION **IGLESIA CRISTIANA TEMPLO DEL ESPIRITU SANTO, INC.** IN THEIR ENTIRETY, AND ADPTOT THE FOLLOWINGARTICLES OF INCORPORATION, AND AGREE AND CERTIFY AS FOLLOWS:

**ARTICLE I**

**NAME**

**ARTICLEIII**

**PURPOSES AND GENERAL POWERS**

1. THE GENERAL PURPOSE OF THIS CORPORATION SHALL BE THE TRANSACTION OF ANY AND ALL LAWFULL BUSINESS. THIS CORPORATION SHALL HAVE ALL OF THE POWERS ENUMERATED IN THE FLORIDA NOT FOR PROFIT CORPORATION ACT, AS THE SAME NOW EXITS AND AS HEREAFTERAMENDED, AND ALL SUCH OTHER POWERS AS ARE PERMITTED BY APPLICABLE LAW.
2. TO HAVE A CORPORATE SEAL, WHICH MAY BE ALTERED AT PLEASURE,AND USE THE SAME BY CAUSING IT, OR A FACSIMILE THEREOF, TO BE IMPRESSED,AFFIXED, OR IN ANY OTHER MANNER REPRODUCED PROVIDED; HOWEVER,SUCH SEAL SHALL ALWAYS CONTAIN THE WORDS "CORPORATION NOT FOR PROFIT".
3. TO PURCHASE, TAKE RECEIVE, LEASE, TAKE BY GIFT, DEVISE OR BEQUEST OR OTHER WISE ACQUIRE, OWN, HOLD, IMPROVE, USE AND OTHERWISE DEAL IN AND WITH REAL OR PERSONAL PROPERTY OR ANY INTEREST THEREIN, WHEREVER SITUATED.

4. TO SELL, CONVEY, MORTGAGE, PLEDGE, CREATE, SECURITY INTEREST IN, LEASE, EXCHANGE, TRANSFER, AND OTHER WISE DISPOSE OF ALL OR ANY PART OF ITS PROPERTY AND ASSETS.
5. TO LEND MONEY FOR ITS CORPORATE PURPOSES, INVEST AND REINVEST ITS FUNDS, AND TAKE AND HOLD REAL PERSONAL PROPERTY AS SECURITY FOR THE PAYMENT OF FUNDS SO LOANED OR INVESTED.
6. TO PURCHASE, TAKE, RECEIVE, SUBSCRIBE FOR, OR OTHERWISE ACQUIRE, OWN, HOLD, VOTE, USE, EMPLOY, SELL, MORTGAGE LEND, PLEDGE, OR OTHERWISE DISPOSE OF, AND OTHERWISE SELL AND DEAL IN AND WITH, SHARES OR OTHER INTEREST IN, OR OBLIGATIONS OF, OTHER DOMESTICS OR FOREIGN CORPORATIONS, WHETHER FOR PROFIT OR NOT FOR PROFIT ASSOCIATIONS, PARTNERSHIPS OR INDIVIDUALS, OR OTHER GOVERNMENT, STATE, TERRITORY, GOVERNMENT DISTRICT, OR MUNICIPALITY OR ANY INSTRUMENTALITY THEREOF.
7. TO MAKE CONTRACTS AND GUARANTEES AND INCUR LIABILITIES, BORROW MONEY SUCH RATES OF INTEREST AS ITS BOARD OF TRUSTEES MAY DETERMINE, ISSUE ITS NOTES, BONDS, AND OTHER OBLIGATIONS, AND SECURE ANY OF ITS OBLIGATIONS BY MORTGAGE OR PLEDGE OF ALL OR ANY OF ITS PROPERTY, FRANCHISES, AND INCOME.
8. TO ENTER INTO, MAKE, RECEIVE ASSIGNMENTS OF, GRANT ASSIGNMENTS OF, AND PERFORM CONTRACTS OF EVERY NATURE AND KIND FOR ANY LAWFULL PURPOSE.
9. TO CONDUCT IS BUSINESS, CARRY ON ITS OPERATIONS, AND HAVE OFFICES AND EXERCISE THE POWERS GRANTED BY FLORIDA. NOT FOR PROFIT CORPORATIONS ACT OR BY OTHER APPLICABLE LAW WITHIN OR WITHOUT THE STATE OF FLORIDA.
10. TO ELECT OR APPOINT OFFICERS AND AGENTS AND DEFINE THEIR DUTIES AND ALLOW THEM REASONABLE COMPENSATION.
11. TO MAKE AND ALTER BYLAWS, NOT INCONSISTENT WITH ITS ARTICLES OF INCORPORATION OF WITH THE LAW OF THE STATE OF FLORIDA, FOR THE ADMINISTRATION AND REGULATION OF ITS AFFAIRS.
12. TO PROMOTE, BY ALL PROPER AND LEGITIMATE AGENCIES AND MEANS, EDUCATION AND EDUCATIONAL INSTITUTIONS GENERALLY, AND ANY AND ALL CHARITABLE, RELIGIOUS, SCIENTIFIC AND EDUCATIONAL MOVEMENTS, PURPOSE OR CAUSES; TO MAKE GIFTS AND DONATIONS FOR THE PUBLIC WELFARE OR FOR CHARITABLE, RELIGIOUS, SCIENTIFIC, EDUCATION PURPOSE OR OTHR SIMILAR PURPOSES

13. TO DEDICATE TO THE PUBLIC OR TO ANY GOVERNMENTAL ENTITY OR OTHER ENTITY WHATSOEVER FOR ANY PUBLIC OR OTHER PURPOSE ANY OF ITS REAL OR PERSONAL PROPERTY OR ANY INTEREST THEREIN.
14. TO TRANSACT ANY LAWFUL BUSINESS WHICH ITS BOARD OF TRUSTEES SHALL FIND WILL BE IN AID OF GOVERNMENTAL POLICY.
15. TO HAVE AND EXERCISE ALL POWERS NECESSARY OR CONVENIENT TO EFFECT ITS GENERAL PURPOSES.
16. THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, SCIENTIFIC, EDUCATIONAL, AND LITERARY PURPOSES, INCLUDING FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OF 1986 (OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW).
17. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSES SET FORTH IN THIS ARTICLE. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE CARRYING ON THE PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF OR OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY (a) A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW OR BY (b) BY A CORPORATION, CONTRIBUTION TO WHICH ARE DEDUCTIBLE UNDER SECTION 170 (C) (2) OF THE INTERNAL REVENUE CODE OF 1986 OR CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.



ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY THE CIRCUIT COURT OF THE CITY OR COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.


