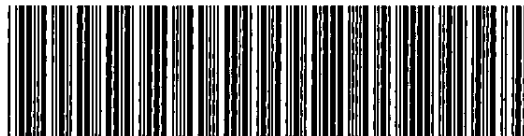

**ARTICLE III**

**Specific Purpose:**

The specific purpose of The Zeta Nu Chapter Housing Corporation is to purchase, construct, own, operate, and manage student housing for persons affiliated with The Kappa Alpha Order chapter at the University of North Florida. It is further the purpose of this corporation to promote in such persons, the advancement of scholarship, leadership ability, and the desire to cooperate with and work in harmony with their fellow man in promoting things of a civic or educational nature, which are for the general good of society, by providing a wholesome, educational, communal living environment for persons affiliated with the Zeta Nu Chapter of The Kappa Alpha Order. In accomplishing this purpose, the Corporation may purchase property and construct housing facilities thereon. In meeting these goals, the Corporation will operate and manage such facilities, in terms of any revenue or expenses attributable thereto, or any other of it's operations, in such a way as to earn no profit.

**ARTICLE IV**

**Manner of Election:**

The Officers and Directors are elected in the manner stated in The Zeta Nu Chapter Housing Corporation Bylaws.

## ARTICLE V

### Officers and Directors:

The Zeta Nu Chapter Housing Corporation will hold it's meetings at the University of North Florida or at such place as a majority of the board of directors deems appropriate at the call of the President of the Corporation or as requested by an two (2) directors.

The officers of the Corporation shall be a President, a Vice President, a Secretary, a Treasurer, and five (5) at-large directors. These officers will be elected by the membership at the annual Corporation meeting, which will take place in February of each year. Each officer will serve a one year term.




