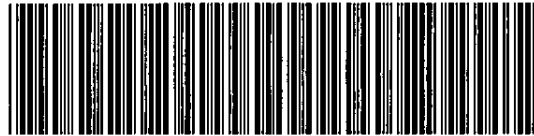

In Compliance with Chapter 617, F.S., (Not for Profit)

## ARTICLE I: NAME

The name of the corporation shall be Digital Church Project, Incorporated.

## ARTICLE II: PRINCIPAL OFFICE
