ARTICLES OF INCORPORATION

OF

We the undersigned, with other persons, being desirous of forming a corporation for charitable, religious and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

I

The name of the corporation is:

The general nature of the purposes of this corporation shall be to provide a place of rest, recreation and Orthodox Jewish religious atmosphere, to conduct religious classes in accordance with the tenets and practices of the Orthodox Jewish faith, to establish a school that will insure the sacred tradition inherent in Orthodox Judaism, and to engage in any other lawful activity as permitted by the laws of the State of Florida that shall specifically fulfill the aforementioned general language.

XI

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

XII

In order to promote the purposes of this corporation, it may acquire property by grant, gift, devise or bequest and hold and dispose of such property as the corporation shall require for the benefit of the members and purposes of the corporation and not for pecuniary profit.

XIII
