ARTICLE III PURPOSE

The mission of Hand in Hand Theater, Inc. is to encourage children's respect for diversity, and to promote tolerance and understanding through theater arts. The use of multicultural literature, including folk and fairy tales, will transcend cultural barriers and evoke themes such as the commonality of values and ways of life, and the acceptance and appreciation of diversity.

The objectives of Hand in Theater are to: (1) engage a diverse population of children, ages, 5-15, in theater that focuses on multicultural and anti-bias themes; (2) offer children, their families, and educators pre-and post-theater workshops and activities; (3) provide teachers with training in the use of activity guides and multicultural literature; (4) integrate literacy skills with theater arts programming, and correlate activities to national standards, (5) develop and disseminate activity guides and kits to students, partners and teacher that will improve communication skills and provide understanding of diversity; and (6) create a web site to feature those guides and provide a forum for educators to share ideas.

ARTICLE IV MANNER OF ELECTION (of directors)

The method of appointment or election of directors is as stated in the by-laws. They are chosen according to experience, knowledge, and interest in theater for children. Positions are open to individuals who qualify, regardless of race, religion, color, sex, age, national origin, marital status, political affiliation, or disability.
