MOSEP 26 A 10: 07

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is Helping Hand Plan will help the uninsured, underinsured, and poor obtain access to medically necessary Doctor Visits, Diagnostic Testing, and Bloodwork that they cannot afford. Donations will be used to pay for these services directly to Medical Providers who agree to perform them for reduced pricing and Helping Hand Plan will only pay for services deemed medically necessary and needed for the patient's treatment.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
