The undersigned incorporator, desiring to form a corporation not-for-profit under Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation is Project Autism of St. Johns, Inc. (the "*Corporation*").

ARTICLE II

The principal office and mailing address of the Corporation in Florida are located at 109 Marsh Island Circle, St. Augustine, Florida 32095.

ARTICLE III

The specific purpose for which this Corporation is organized is to accumulate and raise funds for the benefit of community education and awareness of autism, including, but not limited to, programs, awareness and advocacy.
